THE RONALD MCDONALD HOUSE IN HERSHEY IS A HOME AWAY FROM HOME ENVIRONMENT FOR FAMILIES WHO NEED TO BE TOGETHER AND NEAR THE CARE AND RESOURCES THEY NEED TO SUPPORT THEIR SICK OR INJURED CHILD(REN). IN 2022, WE PROVIDED 892 FAMILIES 7,383 OVERNIGHT STAYS, 3,164 MEALS AND OVERALL BECAUSE OF OUR SERVICES, SAVED OUR FAMILIES A TOTAL OF \$2,384,709. THE AVERAGE STAY OF OUR GUEST FAMILIES WAS 8 NIGHTS WITH THE LONGEST GUEST STAY WAS 284 NIGHTS. TOTAL NUMBER OF PA COUNTIES SERVED WAS 49.
